Applications are now available for those interested in applying for a home in the Hope Meadows subdivision. Hope Meadows Development application is available at any of the Disaster Case Management offices assisting Hurricane Harvey survivors. The VCLTRG, Mennonite Disaster Service, Disaster Aid Ohio, Rio Texas UMCOR, Civil Corp., Cullen Law Firm, First Community Bank of Victoria and other partners have combined their expertise and resources, totaling approximately \$4.6 million, to build 40 homes that will bring surviving families into full recovery. The infrastructure should be complete in the Fall of 2019 with home building beginning shortly thereafter.
